## Tuition Rate and Assistance Applications for the 2024-2025 School Year

Tuition assistance applications will be done online again this year. You may begin the application process starting on March 1st, 2025. **Families who are currently enrolled and seeking assistance must have the application completed by March 31st, 2025.**

As you all know, our funds are limited and those who apply after March 31st are not guaranteed any financial assistance.

If you are seeking assistance, please keep in mind:

- You must file these forms by the stated due date. The fund is limited and you may not be awarded if you do not fill it out on time OR in entirety.
- All forms needed must be included.
- FACTS has a toll free number if you need help filling out your application. It is not something that our office can help you with.

Tuition assistance applications help us assure fairness to all of our families. Tuition contracts with awarded assistance amounts will be sent home to families in the spring.

If you were sexually abused by any person connected with the Diocese, a Catholic parish, or Catholic school within the geographic area of the Diocese, or have any claim against the Diocese, you must file a claim by **April 4, 2025**.
